The purpose of this project was to increase the availability of rapid rehousing units for survivors of domestic violence in our community, aligning with Strategic Priority 2 of the Indianapolis Community Plan to End Homelessness. Our previous HUD grant proposed to serve 17 DV survivors, but our two expansion projects proposed more than 70—an increase of more than 300% that strained our organizational capacity. At the time the grant started, we had three housing advocates on staff, and it was not until early 2021 that we had fully staffed the Housing Team, more than four months into the grant period. Coburn Place’s client intake and financial management structures also proved slow and inadequate to keep up with such rapid growth. At the same time, Coburn Place was still adjusting to the crisis that COVID-19 inflicted on survivors, unprecedented numbers of incoming clients, and the tight local market for affordable housing. As a result, grant spending was significantly behind schedule.

We started the current grant cycle in a much stronger position. The team is fully staffed, and we had begun pulling more clients in from Coordinated Entry System. In 2022, pursuant to our refocused mission and program design, we have established referral-based partnerships with other DV providers in the community in addition to pulling clients from the Coordinated Entry System, which will give us a wider pool of clients who are homeless due to DV to place in housing. Additionally, we recently hired a Grants Finance Manager, who is working with the Housing team to provide accurate and revolving projections around how many clients we can house based on the funds available. In June 2022, we met with the City of Indianapolis and learned about more efficient ways to leverage our funding from this project, especially around supportive services and rental assistance funds. A portion of HUDDV funds will also support a new Housing Navigator position. This position will be responsible for searching for and securing housing with clients. Using Padmission, housing partnerships, and relationships with properties, this position will reduce the time it takes to secure housing for new clients.

With the 2020-2021 project, we had only expended 6% of funds by the six-month mark. In our current project, we expended 28% of funds by the six-month mark. Significant staff turnover and training needs related to a program redesign caused a temporary reduction in the amount of funds expended on the grant in the first half of the year. Our team is nearly staffed again, including a dedicated Intake Specialist, and clients are flowing in to the program. We anticipate that, for the current program, we will not reach 85% but will likely reach between 50% and 55%. Although this is not the 85% threshold, it is a significant improvement from the previous grant program. We are confident that with our new processes and initiatives, we can appropriately spend these funds in future years.

The target population is survivors of intimate partner violence. All housing clients are processed through the Coordinated Entry System. Once a unit is identified, clients work with a Community Housing and Outreach Advocate to maintain housing and receive services. Clients create a Personal Plan for Independence focusing on the individual goals they hope to achieve. At full capacity, there will be 42 households participating in Community Housing and Outreach Services. Coburn Place does not place geographic restrictions on program participants, however, a majority of the clients are from Indianapolis. The target population will be clients who are rapidly re-housed into 42 community based-housing units. Specific addresses of the 42 units are unknown at this time.

Clients will work with an Advocate to access supportive services. Coburn Place anticipates achieving the following outcomes: 80% will improve their level of self-sufficiency; 100% maintain permanent housing for 3 months; 80% will be aware of their economic self-sufficiency status by calculating the Self-Sufficiency Standard Measure; staff will coordinate with partner landlords; financial and economic empowerment coaching and support will be provided by staff and partners; and referrals to partners will be provided for job readiness, employment, training, educational programs, domestic violence shelters, counseling, law enforcement, mental health facilities, hospital, and prosecutors.

The timeline is 9/1/20 - 8/31/21 and units will be leased as soon as clients are identified. Coburn Place participates in the City's Homeless Management Information System by providing data at an aggregate level only since it is a domestic violence service provider. Coburn Place participates in the Housing Committee that identifies clients for housing options within the community. Advocates work with clients to determine their Medicaid eligibility and assist with enrollment.
