Coburn Place proposes to expand its Rapid Re-Housing and Advocacy Program. At least 56 individuals, families and households on the Coburn Place currently on the waiting list meet the criteria for the program and will be rapidly rehoused into 29 rental units located in the community. Clients meeting eligibility requirements for this program will have fewer self-sufficiency barriers and domestic violence lethality than those clients residing in the Coburn Place facility.

Once in a rental unit, clients will work closely with an Advocate to access supportive activities within Coburn Place’s four pillars, including: 1) Immediate and Long-Term Safety; 2) Social and Emotional Well-Being; 3) Housing Readiness; and 4) Self-Sufficiency.

Adult clients will have the opportunity to participate in activities such as: therapy; support groups; crisis counseling; educational classes; employment training and readiness; substance abuse recovery and prevention; family development support; financial literacy; criminal justice advocacy; childcare; and referrals to established community partners.

Clients in the Rapid Re-Housing and Advocacy Program will pay income based rent while receiving rental and utility assistance from Coburn Place. As goals are achieved, Coburn Place Advocates will continue to assess the level of rent and utility assistance provided and scale it down to tiered levels as appropriate so that self-sufficiency may be achieved by program’s end.
