The Blueprint Council has designated CHIP as the CoC Lead agency to drive the strategies within the Community Plan to End Homelessness. CHIP holds and communicates the vision for stakeholders and creates a culture of transformative learning, evaluation, and adaptive programming. Project managers lead an intentional change process supported by a balanced governance and implementation infrastructure and utilize work plans to track progress toward achieving the Community Plan goals.

Key Planning Priorities are anchored with a lens of racial equity and ensure the effective engagement of persons with lived experience across the CoC. These priorities include:

- Develop, implement, and manage an online learning management system for the onboarding of new staff and agencies.
- Create specific strategies and action plans to address unsheltered homelessness and family homelessness.
- Improve efficiencies within the rehousing systems using the HomeNow Indy model (i.e., system facing housing navigation, dedicated housing focused outreach, centralized fiscal administration, and flex funding pool).

CHIP will continue developing the CoC system by supporting the CoC governance structure (governing council, charter, written standards, standing committees, and workgroups) and cross-system partnerships with the local public housing authority, public health entities, and affordable housing providers.

As the Lead agency managing the NOFO process, one of our initial tasks is to design a review and ranking process for local programs that considers current HUD scoring criteria and policy priorities. CHIP will ensure effective communications and support of community engagement, as well as write the grant application.

CHIP will develop and implement a cohesive communications strategy within the CoC and broader community, utilizing website and social media platforms, biweekly provider emails, and virtual meetings. We will also hold CoC convenings such as quarterly meetings for the full membership with published agendas.

Further actionable strategies include developing and maintaining performance dashboards at an aggregate community level as well as disaggregated, project level. A shared system of performance measurements will build community-wide capacity to understand and utilize data, which is vital to ensuring alignment of activities and improving performance across the system and within individual projects.

In collaboration with HMIS and in alignment with HUD guidance, CHIP will manage an effective PIT Count of sheltered and unsheltered persons experiencing homelessness including recruiting, coordinating, and training partners and volunteers in support of an accurate count and continually looking at ways to improve methodology.

The community uses a System Performance Dashboard, updated monthly, with six key metrics to understand community performance and provide project outcomes. This includes measuring data completeness, homeless entries, bed utilization, returns to homelessness, average length of stay, and exits to permanent housing. CHIP facilitates monthly meetings with HMIS Users, Super Users, and Site Administrators. Within those meetings, CHIP uses data visualization to drive accountability and inform ongoing strategies for improving project performance. Data is examined at the aggregate system level as well as disaggregate project level. CHIP will collaborate with the Collaborative Applicant to utilize the HMIS Data Quality Plan, program compliance requirements, and CoC Written Standards to implement a comprehensive evaluation of project performance. The comprehensive effort will include monitoring, site visits, and quarterly meetings. A full-time staff provides technical assistance and onsite training to projects with a focus on improved performance and outcomes. Project level outcome measures are reported to projects monthly through the System Performance Dashboard, monthly HMIS committee meetings, and community performance criteria for CoC funding are overseen by the non-conflicted work group and approved by the Blueprint Council. Performance drives ESG funding decisions and CoC renewal and reallocation decisions. The planning grant supports ongoing efforts to align ESG and CoC scoring tools with the System Performance Dashboard. FTEs funded through this grant collaborate with this work group to review and update policies annually, assess outcomes measures and update them as needed, create data dashboards for data visualization, and work in coordination with the HMIS team and their work plan to ensure data quality and opportunities to improve outcomes are pursued. They will also work with the CES team to implement the Coordinated Entry Refinement Plan, which includes quantitative and qualitative performance measures.
