CHIP is designated as the CoC Lead through a formal MOU with the Blueprint Council governing board of the CoC and is charged with orchestrating strategies within the five-year Indianapolis Community Plan to End Homelessness (2018-2023). Identifying, implementing, and monitoring outcomes of strategies to end homelessness requires robust data collection and analysis. The 2023 CoC Special Planning Grant will enhance data collection and analysis by enhancing Indianapolis’s annual unsheltered point-in-time (PIT) count through the acquisition and use of the Institute for Community Alliances (ICA) PIT/HIC portal. The portal will bolster planning, execution and analysis of data collection regarding unsheltered homelessness through the following features:

- oConditional logic prompts for HUD-required data fields including age, family/household type, and veteran status
- oGeographic information system (GIS) locator to enhance location specificity, providing greater insight into the geographic areas within the CoC that individuals and families experience unsheltered homelessness
- oReducing incidence of count duplications by applying unique identifiers
- oFacilitates inclusion of non-HMIS participating service providers and allows for population and sub-population data with the same data quality enhancements to ensure a complete and correct count
- oCustomizable features and questions to collect locally interested data points
- oQuality assurance review to ensure removal of duplicates and submissions that do not meet the definition of unsheltered homelessness

Use of the portal will elevate Indianapolis’s annual unsheltered PIT Count by improving methodology, strengthening partnership with street outreach and community partners to ensure a more robust and accurate unsheltered count. The Planning Grant will be used to collaborate with local grassroots organizations, veteran and youth serving organizations and individuals with lived expertise to bolster outreach efforts and ensure those who are least likely to request assistance are identified and engaged. Utilizing geographic location features of the portal will allow for greater analysis of the locations individuals and families experience homelessness. A more accurate unsheltered count will inform community strategies for housing focused, targeted outreach ensuring all persons experiencing unsheltered homelessness within the CoC’s geographical area are identified, engaged, and connected to housing. The unsheltered planning grant will also be used to work with ICA to create questions specifically around first time homelessness and why people are returning to homelessness after being housed. The goal is that these questions can better inform the community as to why people become homeless and how to prevent returns to homelessness in the future.

Secure use of PIT/HIC portal through contract with ICA. Annually in August
Through collaboration with PIT Committee, customize PIT questions to capture locally interested data points. Annually in September
Train street outreach teams and community volunteers on use of PIT portal. Annually in January
Conduct PIT in accordance with HUD standards using portal. Annually in January
Clean, scrub, and deduplicate data entered into portal. Annually

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

The requested funds will improve coverage and data captured for unsheltered households across the CoC's geographical area. This information will be used to support ESG funded street outreach projects in engaging and serving those least likely to present for assistance. Through greater knowledge and understanding of where persons experiencing unsheltered homelessness are across the CoC, the CoC will be able to monitor and evaluate the way in which people get connected to housing and services. A Coordinated Entry Monitoring dashboard will monitor and track CoC and ESG project participation by living situation to foster equity in access to housing and services.
