HIP is requesting \$404,930.00 to provide RRH and services for 25 households including 10 individuals and 15 families with children. HIP CoC RRH clients will be housed in scattered site locations throughout the community based on their housing needs. As an RRH provider for over 10 years, HIP has formal collaborations with 20+ housing providers throughout the City. These housing providers include apartment communities and private landlords with single family dwellings.

HIP Case Managers (CM) assist in removing barriers to obtaining housing. CMs focus on individual strengths to make sure each member of the household has a path towards his/her idea of success, such as: getting kids enrolled in early education; increasing budgeting skills; selecting appropriate housing; learning how to be a good tenant and neighbor; participating in employment and training services; ensuring access to medical, mental health and addiction services, and ensuring access to a certified health navigator for health insurance benefits, a SOAR specialist, and other mainstream benefits and services to alleviate future housing and personal crisis. This includes HIP's established relationships with mental health and substance abuse treatment providers, domestic violence shelters and organizations, LGBTQ service providers, Centers for Working Families, WorkOne, SNAPs, childhood educational support (Head Start and CCDF), the Children's Bureau, NACs, and Healthy Families.

HIP will begin services on day 1 of the contract and serve the number of households identified with the first 90 days of the contract. Through ongoing budgeting, case conferencing, and report evaluations, HIP is prepared to serve at least 30% more than the number identified, with 95% of households housed within 45 days and 85% permanently housed at time of closing.

All HIP staff are trained to accept household referrals through the Indianapolis Coordinated Entry System and HMIS; and are trained in HMIS data entry and reporting.

This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in September 1984 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in section 509(a)(3).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.

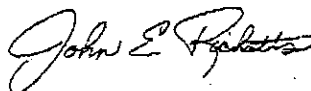

You may be liable for a penalty of \$20 a day for each day you do not make these documents available for public inspection (up to a maximum of \$10,000 in the case of an annual return).
