The target population is survivors of intimate partner violence. All housing clients are processed through the Coordinated Entry System. Once a unit is identified, clients work with a Community Housing and Outreach Advocate to maintain housing and receive services. Clients create a Personal Plan for Independence focusing on the individual goals they hope to achieve. At full capacity, there will be 42 households participating in Community Housing and Outreach Services. Coburn Place does not place geographic restrictions on program participants, however, a majority of the clients are from Indianapolis. The target population will be clients who are rapidly re-housed into 42 community based-housing units. Specific addresses of the 42 units are unknown at this time.

Clients will work with an Advocate to access supportive services. Coburn Place anticipates achieving the following outcomes: 80% will improve their level of self-sufficiency; 100% maintain permanent housing for 3 months; 80% will be aware of their economic self-sufficiency status by calculating the Self-Sufficiency Standard Measure; staff will coordinate with partner landlords; financial and economic empowerment coaching and support will be provided by staff and partners; and referrals to partners will be provided for job readiness, employment, training, educational programs, domestic violence shelters, counseling, law enforcement, mental health facilities, hospital, and prosecutors.

The timeline is 9/1/20 - 8/31/21 and units will be leased as soon as clients are identified. Coburn Place participates in the City's Homeless Management Information System by providing data at an aggregate level only since it is a domestic violence service provider. Coburn Place participates in the Housing Committee that identifies clients for housing options within the community. Advocates work with clients to determine their Medicaid eligibility and assist with enrollment.
